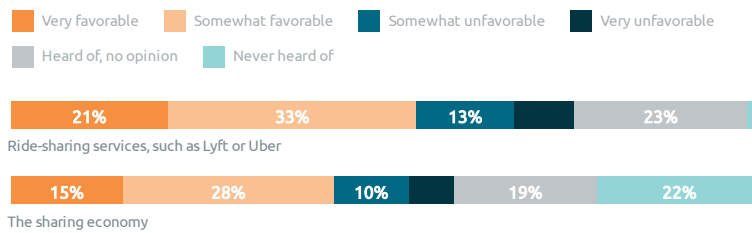

THE IMPACT OF RIDE-SHARING

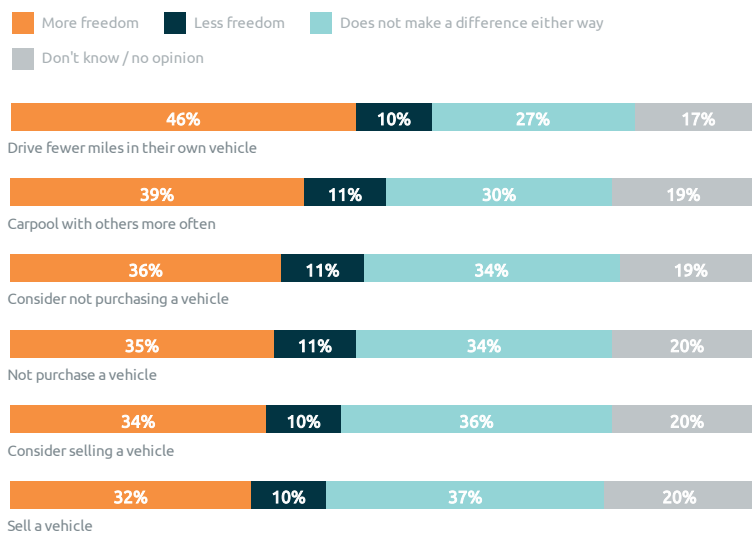
Majority of voters (54%) hold favorable views of ride-sharing services

Do you have a favorable or unfavorable view of each of the following?



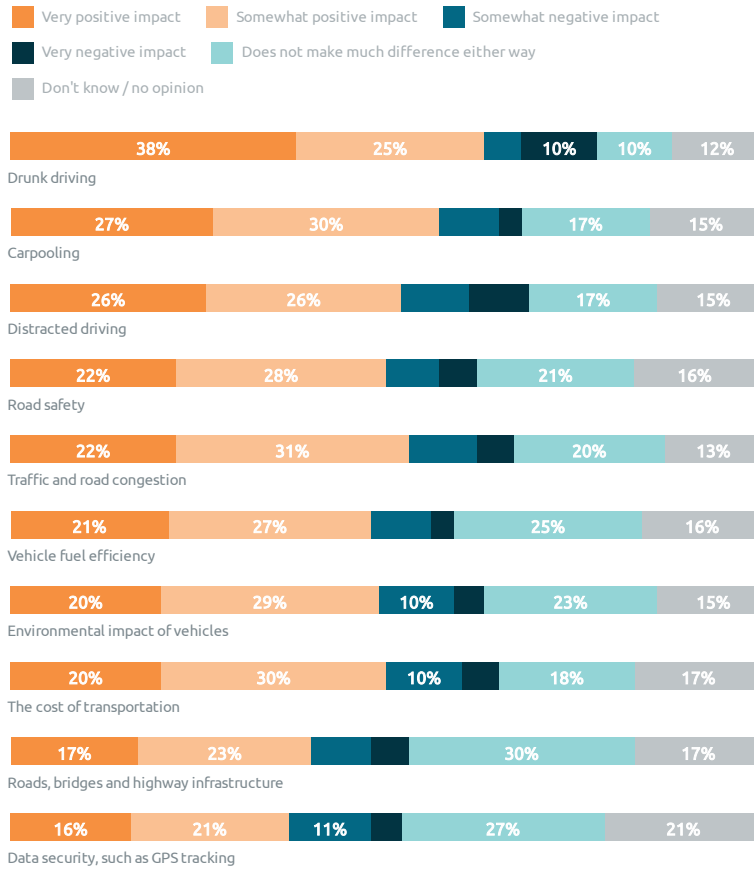
Pluralities say access to ride-sharing services allows consumers more freedom to drive fewer miles and carpool more often

And generally, do you believe access to ride-sharing services such as Lyft or Uber gives consumers more or less freedom to...



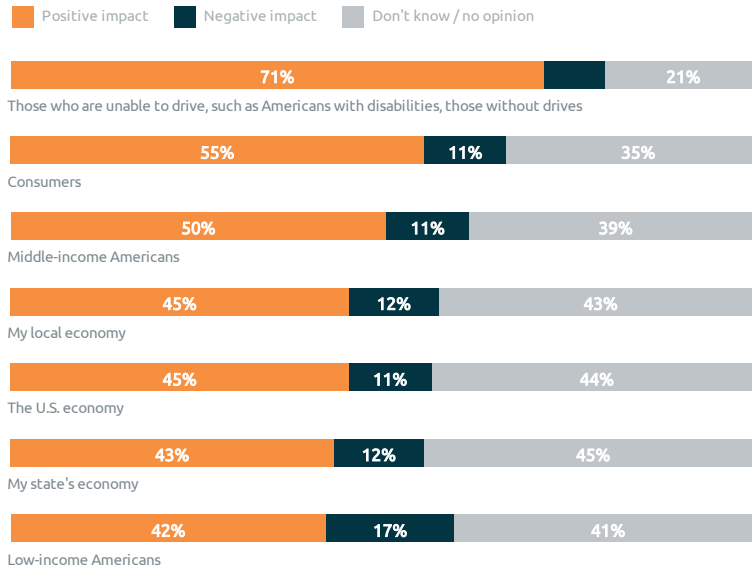
And they recognize ride-sharing's positive impact on safety issues such as drunk and distracted driving...

When it comes to road and transportation issues in your local area, do you believe ride-sharing services such as Lyft or Uber have a positive or negative impact on each of the following?



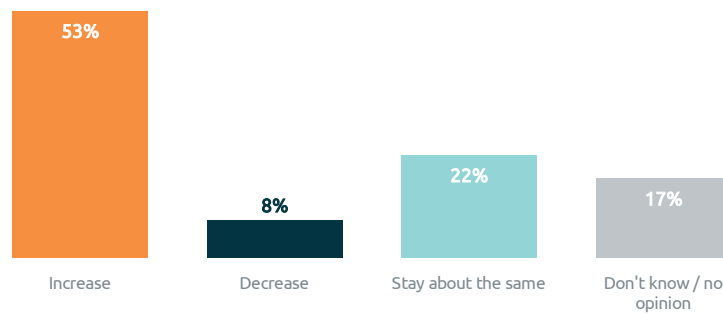
...In addition to Americans with limited mobility

Generally, do you believe ride-sharing services such as Lyft or Uber have a positive or negative impact on each of the following?



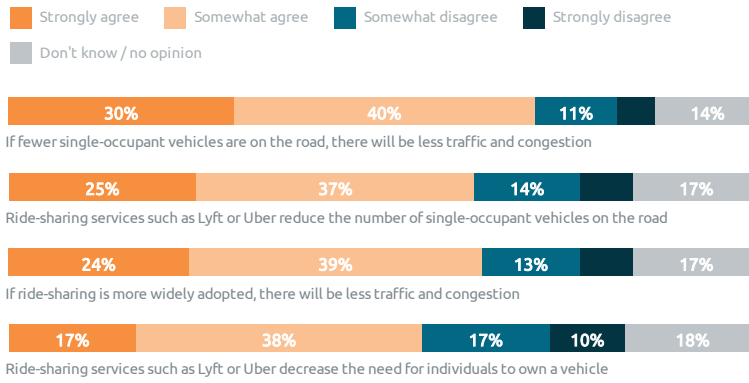
Voters predict consumer use of ride-sharing will Increase over next ten years...

...Which will ultimately lead to less traffic and congestion due to the reduction in single-occupancy vehicles on the road

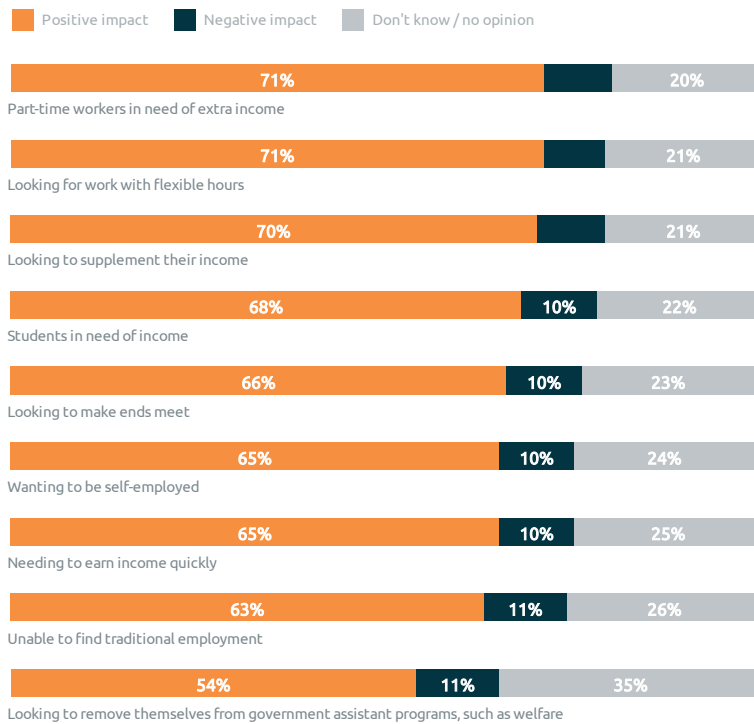

RIDE-SHARING WORKERS

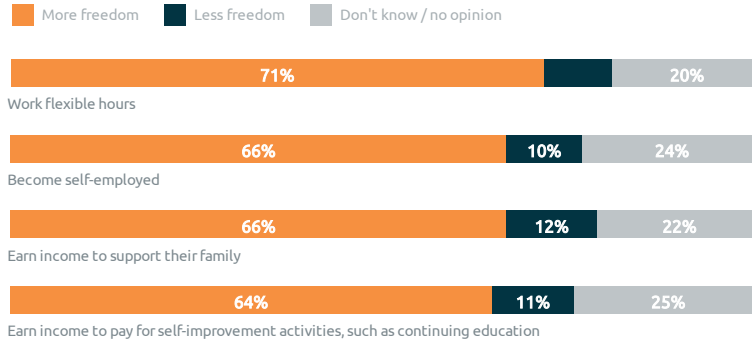
Overwhelming majority say ride-sharing has positive

impact on each of the following? Individuals who are...



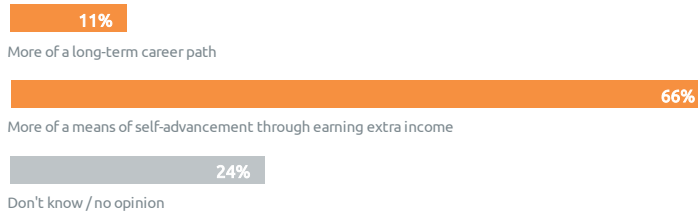
These platforms also allow flexibility and freedom for workers who need it most

Do you believe drivers earning money via ride-sharing apps such as Lyft or Uber have more or less freedom to...



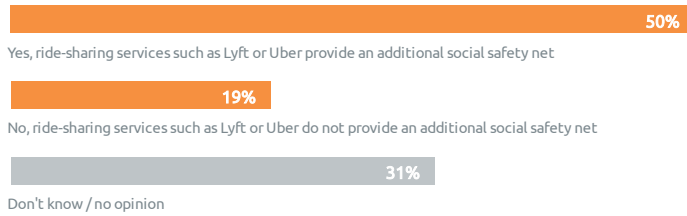
2 in 3 voters recognize ride-sharing opportunities as a means of self-advancement

And by a 31-point margin, the opportunity to earn income via ride-sharing platforms is seen as an additional social safety net

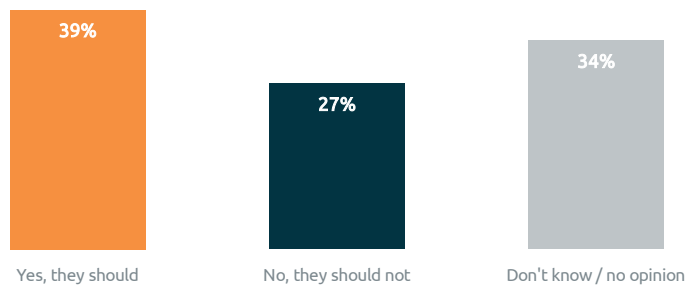
And, do you believe ride-sharing services such as Lyft or Uber provide an additional social safety net that allows individuals to earn income when they are in need, or not?



GOVERNMENT REGULATION

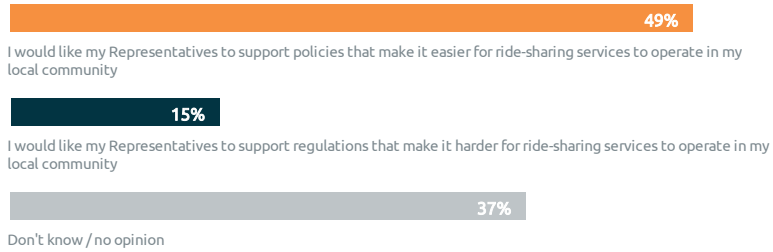
Most voters want local governments to incorporate ride-sharing companies into the planning of future transportation policies

Should your local government incorporate ride-sharing companies into the planning of future transportation policies and investments, or not?



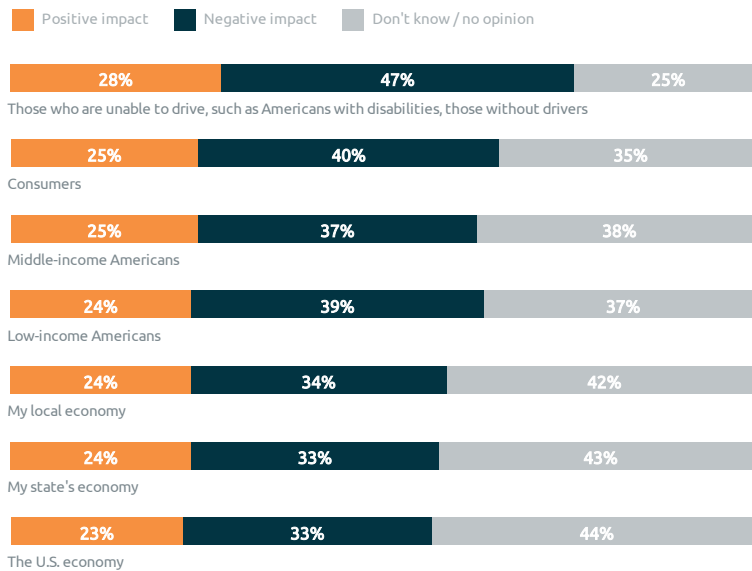
And by a 34-Point margin, they want their Representatives to support policies that make it easier for ride-sharing platforms to operate in their local community
